Michael Driscoll's career spans 35 years in manufacturing and management; at Winchester Electronics, a global leader in the design, development and deployment of high-speed interconnect technology, he served as President from 2000 through 2006, President and Chief Executive Officer from 2006 through 2010 and company Chairman until its sale in 2014; following Winchester Electronics, Driscoll served as Executive in Residence for five and a half years at Connecticut Innovations, the State of Connecticut's Venture Fund, where he worked with Connecticut based start-ups helping them develop and implement business strategies, manage their finances, and raise capital for continued growth. Declan Hill

Declan Hill, Ph.D., is an Associate Professor of Investigations, University of New Haven. Dr. Hill specializes in the study of organized crime and corruption specifically in international sport. He is the author of *The Fix: Organized Crime, and Soccer* and *The Insider's Guide to Match-Fixing in Football* as well as numerous peer-reviewed academic articles on the subject of sports corruption and gambling. Hill is a former investigative journalist and news presenter for the *Canadian Broadcasting Corporation (CBC)*. His work has also appeared in *The New York Times*, *BBC*, *PBS Frontline*, *Der Spiegel*, *The Guardian*, *The Sunday Telegraph*, and *The Times* (London). Hill has penned stories on the murder of the head of Canadian mafia, Honour Killings in Kurdistan, Blood Feuds in Kosovo, the Underground Railway for Iraqi women and the close connections between National Hockey League stars and the Russian Mafiya. Dr. Hill has won numerous awards for his work, including Amnesty International's Best Human Rights Documentary, and recognition by Play the Game (Denmark) and the Canadian Association of Journalists. He speaks fluent English, French, Spanish, and Italian.



Michele Roberts

Prior to her retirement in January 2022, Michele Roberts served as the Executive Director of the National Basketball Players Association (2014-2021), working on behalf of NBA players to ensure their rights were protected and they were fairly compensated for the value they brought to the sport and their impact on the community; prior to joining the NBPA, she was a trial lawyer with Skadden, Arps, Slate, Meagher & Flom where her practice focused on complex civil and white-collar criminal litigation before state and federal courts and in administrative proceedings; Roberts has tried more than 150 cases to jury verdicts, representing clients in a wide variety of areas, including products liability, white collar, racketeering, securities regulation violations, Title VII issues and premises liability; she is a Fellow of the American College of Trial Lawyers and frequent lecturer and presenter to both the bench and bar on a variety of topics related to litigation and trial practice; Roberts worked for eight years in the office of the Public Defender Service for the District of Columbia, where she was named Chief of the Trial Division; she taught trial advocacy as an adjunct member of the faculty at Harvard Law School and as an instructor with the National Institute of Trial Advocacy; Roberts currently serves on the boards of Cresco Labs, The Marshall Project, The Bronx Defenders, and Wesleyan University, her alma mater.
